Course Introduction

The course Leadership in Sports Law (Africa) is a five-week online course (every Tuesday, two hours online), offered by the Academy of Leadership Sciences Switzerland.

The course is designed and delivered by recognized experts in Sports Law. It is being offered as an open course and can be attended by anyone who is, or aspires to get, involved in the industry of sports - including sports administrators, lawyers, sports agents, or intermediaries, current and former athletes, among others.

Course content

The course covers specific topics on sport-related issues including an introduction into sports law, Leadership in Sport, sport governing bodies, sports governance, anti-doping, dispute resolution, Court of Arbitration for Sports (CAS) and other topics.

Accreditation and certification

The Academy of Leadership Sciences Switzerland (ALSS) is an international education institution that offers continuing education, further education, and post graduate advanced education courses, workshops and programs focusing on advanced studies in Leadership and Management. The ALSS also offers short courses that are not credit-bearing, and do not lead to formal qualifications.
